What do you want?

We would like access to exam scripts after they have been marked.

This policy should include:

- 1. **Details of Scripts Provided**: Scripts should include examiner annotations, feedback, and the grading criteria used during marking to ensure clarity and usefulness for learning.
- 2. **Format**: Scripts should be available electronically or for in-person review, depending on the institution's resources.
- 3. **Location/Timing**: Access should be granted within two weeks of results being released, allowing sufficient time for students to review their performance while the material is still fresh in their minds.
- 4. **Opportunity for Review**: Students should have the option to discuss their marked scripts with tutors or examiners for clarification or further guidance.
- 5. **Course Review Integration**: Feedback gained from exam script reviews should inform ongoing improvements to the course. Students should be able to share insights with course leaders to enhance teaching methods, assessment styles, and curriculum design.

Why do you want it?

To better understand our mistakes and improve, with a broader aim of fostering better academic and personal outcomes.
